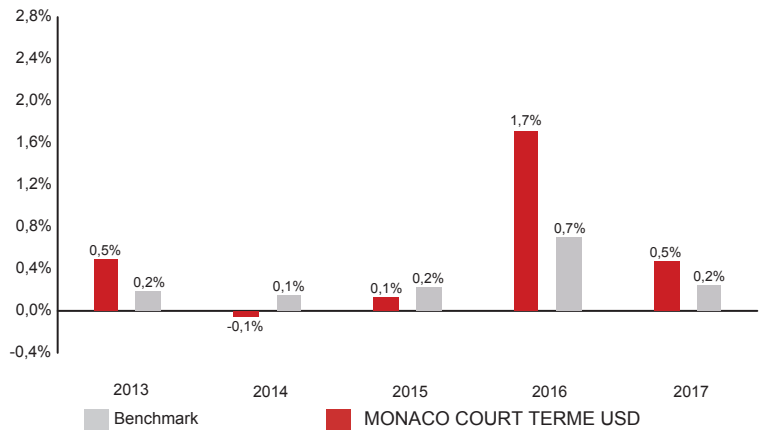

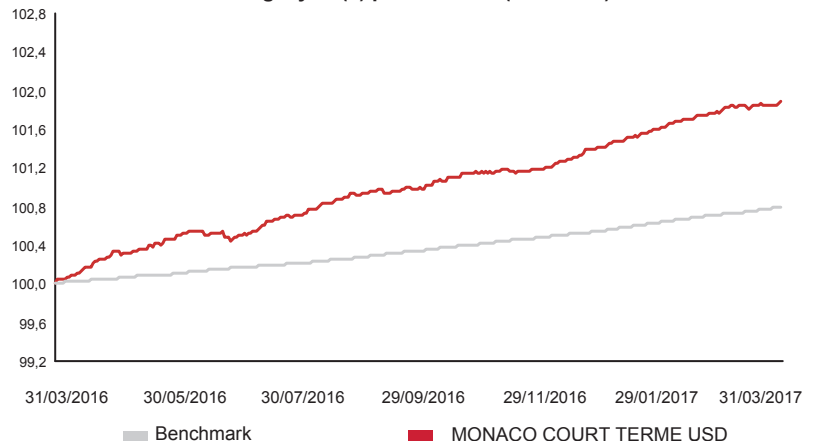

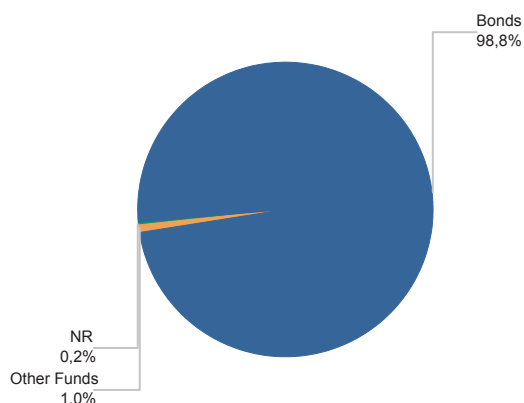
Trailing 1 year(s) performance (basis 100)
