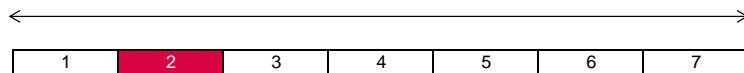
The fund **MONACO EXPANSION USD** invests in both private issuer and sovereign bonds in the "Investment Grade" category which are denominated in USD.

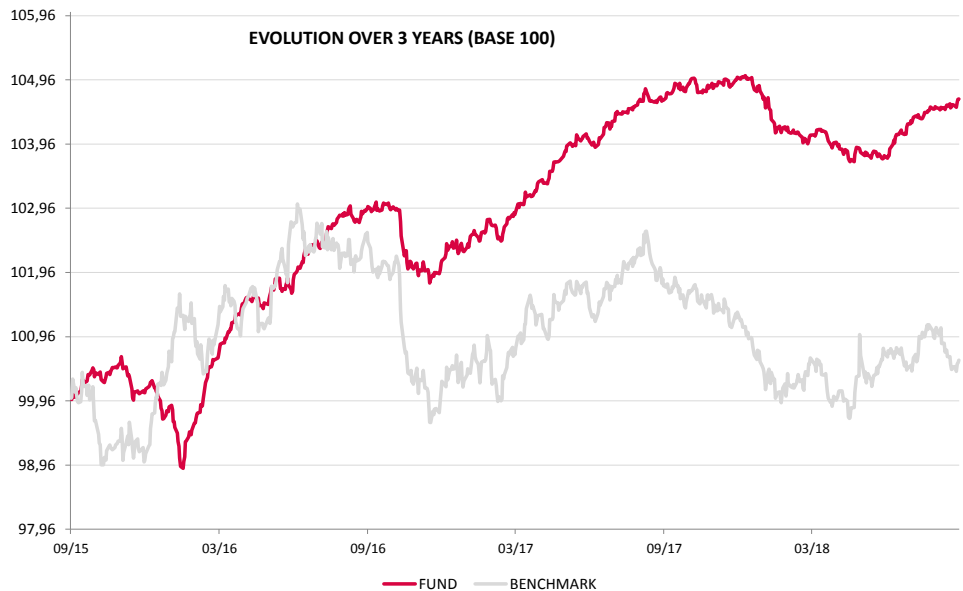

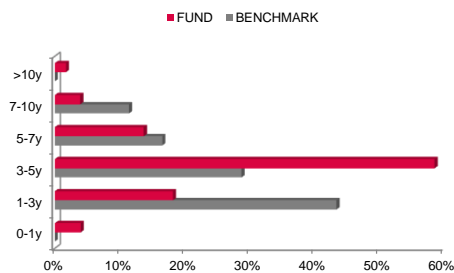
SECTOR ALLOCATION



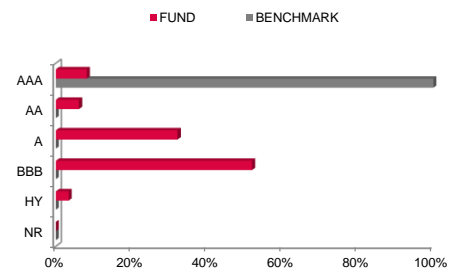
COUNTRY ALLOCATION
