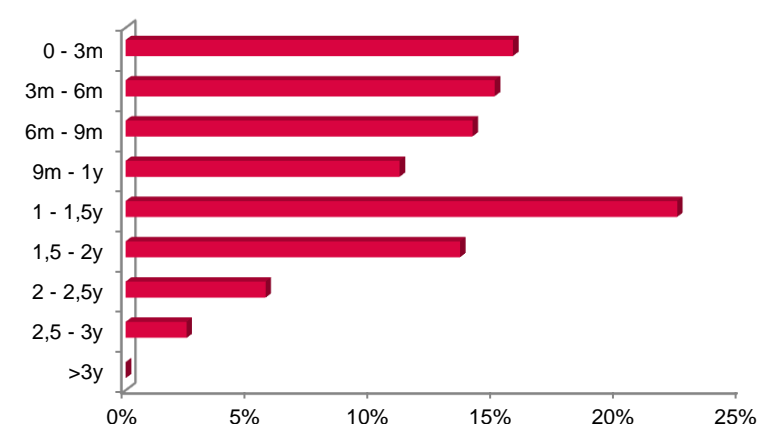
SECTOR ALLOCATION



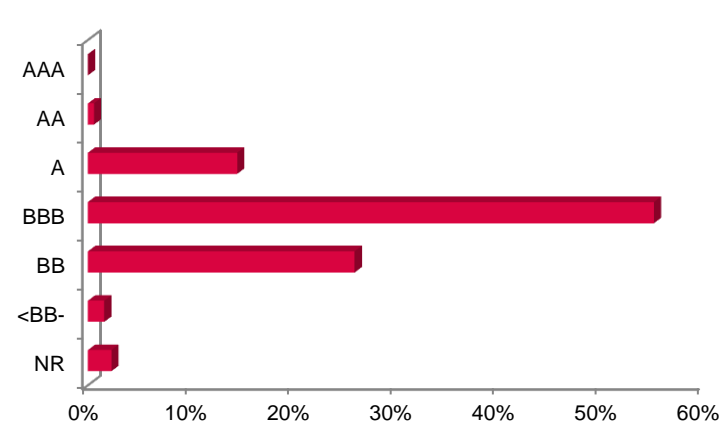
COUNTRY ALLOCATION
