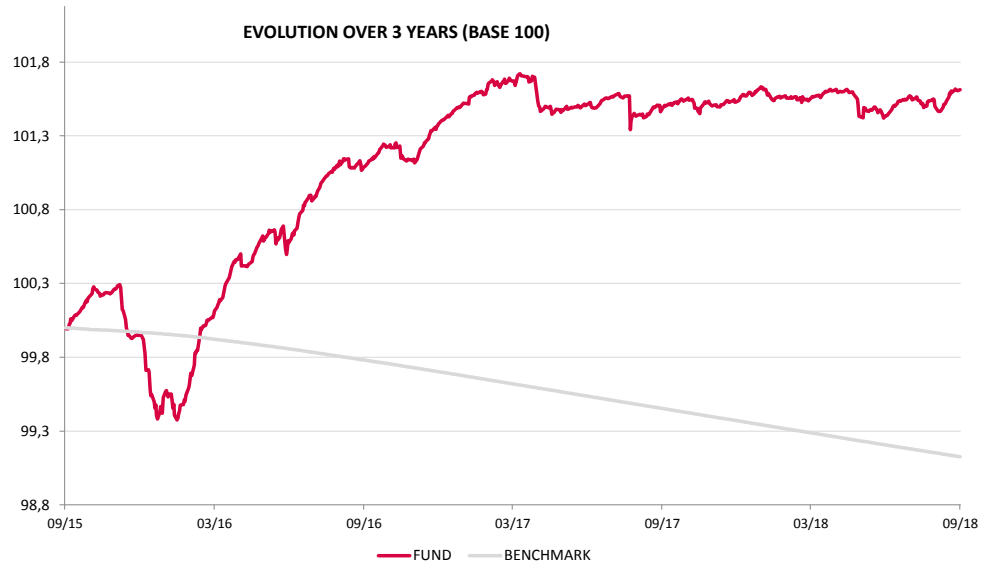

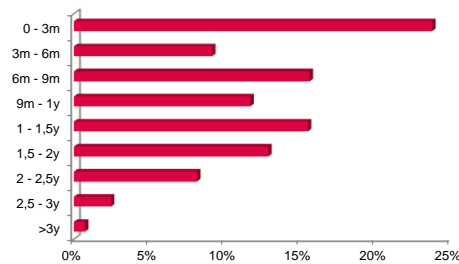
SECTOR ALLOCATION



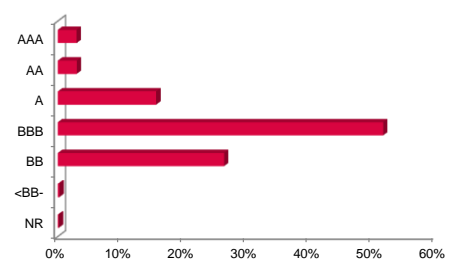
COUNTRY ALLOCATION
