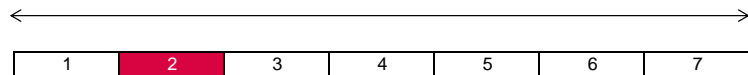
The fund **MONACO EXPANSION EURO** invests in both private issuer and sovereign bonds in the "Investment Grade" category which are denominated in euros.

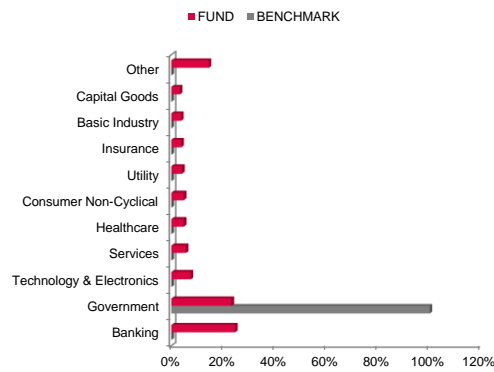

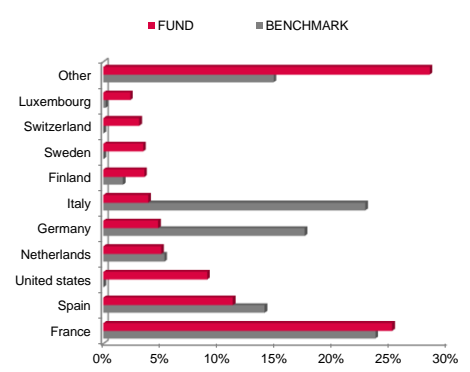

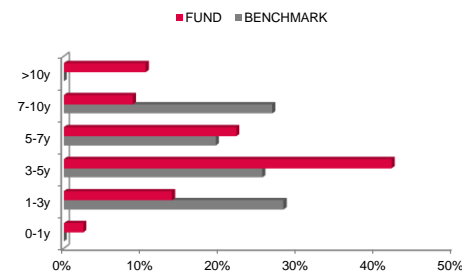
SECTOR ALLOCATION



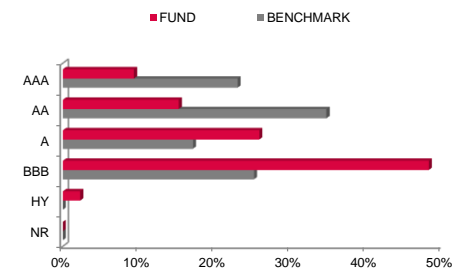
COUNTRY ALLOCATION
