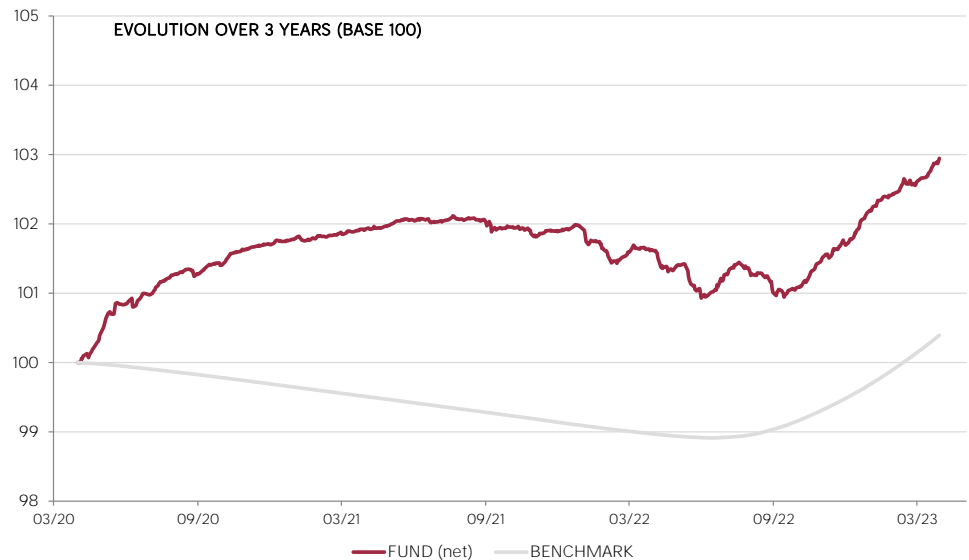

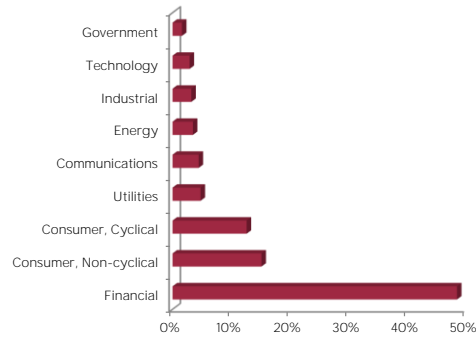

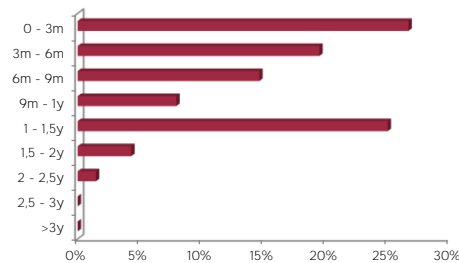
SECTOR ALLOCATION



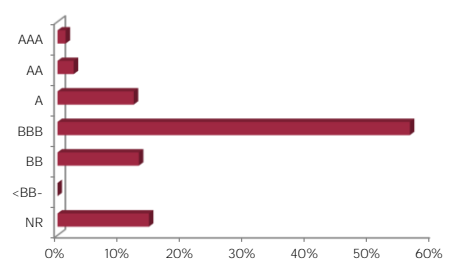
COUNTRY ALLOCATION

MANAGEMENT COMMENT

Euro and US 2-year sovereign rates have remained at similar levels despite significant volatility. There is two positioning, Central bank rates remain higher than market levels as inflation is still high with 7% in March for the Eurozone. Markets are already anticipating rate cuts because economic activity is showing a slowdown with these high rates. On the credit side, UBS is making progress in its acquisition of Credit Suisse and JPMorgan has acquired First Republic Bank, which was seeing its outstandings melt away. In this turbulent environment, the portfolio has a low duration and is 86% invested in investment grade bonds. The fund's carry is +3.97% gross.
